1 **Q1. Please state your name, position, and business address.**

2 A1. My name is Kristin Carlson, and I am Vice President of External, Strategic, and
3 Regulatory Affairs for Green Mountain Power (“GMP”). My business address is 163
4 Acorn Ln, Colchester, VT 05446.

6 **Q2. Have you previously testified in this proceeding?**

7 A2. No. My testimony here is to present the Term Contract which represents a settlement of
8 multiple issues between GMP and GlobalFoundries, including the exemption from the
9 Power Supply and Exogenous (Major Storm) Adjustors proposed for the term of the
10 Regulation Plan.

17 **Q4. What is the purpose of your testimony?**

18 A4. I testify in support of the proposed Term Contract between GMP and GlobalFoundries
19 that both parties jointly submitted to the Commission for approval pursuant to 30 V.S.A.
20 § 229 and which is attached to my testimony as *Exhibit GMP-KC-1*. I also sponsor my

1 testimony and exhibits from that proceeding as ***Exhibit GMP-KC-2***, which contains a
2 much more detailed explanation of the terms of the agreement and the reasons why GMP
3 believes it is appropriate for the company and its customers. The specific effects of the
4 Term Contract on this proceeding are further described in the Supplemental Prefiled
5 Testimony of Edmund F. Ryan.
